PAVEMENT CHIP SEALING SPECIFICATIONS Town of Buchanan

A. Competitive Sealed Bidding

The Town of Buchanan, Wisconsin (hereinafter referred to as the "Town") will receive sealed bids from qualified Contractors for Pavement Chip Sealing Services that are identified in this document. Sealed bids must be received by the date and time listed in these specifications and attached advertisement.

B. Objective/Expectations

These specifications and included contract are for the **2023** Pavement Chip Sealing Services for the Town of Buchanan. The specifications contained herein detail how the Contractor shall maintain right-of-ways (roadways) and other properties in an appropriate, aesthetic and safe manner while doing the work.

C. Qualifications of Contractors

The Contractor, prior to award of the work, shall show to the complete satisfaction of the Town, that it has the necessary facilities, ability and resources to provide the services specified herein in a satisfactory manner. The Contractor shall be required to provide information relative to their respective business and references in order to satisfy the investigations deemed necessary and proper to determine the ability of the Contractor to perform the work. The Town reserves the right to reject any bids if the evidence submitted by, or investigation of the Contractor fails to satisfy the Town that the Contractor is property qualified to carry out the obligation of the contract and to complete the work outlined herein.

Evaluation of the Contractor's qualifications shall include:

- 1. The ability, capacity, skill and resources to perform the work or provide the services required.
- 2. The ability of the Contractor to perform the work or provide the service promptly or within the time specified, without delay or interference.
- 3. The character, integrity, reputation, judgement, experience and efficiency of the Contractor.
- 4. The quality of performance of previous contracts or services.
- D. Insurance and Workers Compensation

The Contractor shall furnish evidence of all listed Workers Compensation, General Liability, Auto and Umbrella insurance coverages. Certificate(s) of Insurance shall be

filed with the submitted bid/contract forms with the Town of Buchanan name as an "additional insured".

To the fullest extent permitted by law, the Bidder shall indemnify and hold harmless the Town and its agents against all injuries, deaths, strikes, losses, damages, claims, suits, liabilities, judgements, costs and expenses which may arise from any negligence of the Contractor, its employees and subcontractors.

E. Examination of Work Sites

Before submitting a bid, each Contractor shall make all investigations and examinations necessary to ascertain all site conditions and requirements affecting the full performance of the contract. If the Contractor receives an award as a result of their bid submission, failure to have made such investigations and examinations will in no way relieve the Contractor from their obligations to comply in every detail with all provisions and requirements of these specifications and contract documents. Nor will the Town accept a plea of ignorance of such conditions and requirements as a basis for any claim whatsoever by the Contractor for additional compensation.

F. Quantities

The road mile quantities shall be construed as estimates for the purpose of obtaining prices and should be verified by the Contractor. The Town reserves the right to increase or decrease the stated quantities based primarily on the Town's budget for the work.

G. Award of Contract

The Town reserves the right to reject any and all bids/proposals, to award multiple contracts, and accept the bid/proposal most advantageous to the Town, even if the bid/proposal is not the lowest in cost.

Contractors should bid using a unit price per foot for pavement chip sealing. All bids shall be accompanied with confirmation for the full amount of footage requested to be chip sealed.

The award shall be made to the responsible bidder or Contractor with the ability to fulfill the Town's contractual needs.

Based on the Town's budget for the work, the Town retains the ability to reduce the number of roadway feet to be chip sealed in order to meet its budgetary goals. Conversely, should the budget allow, additional roadway to be chip sealed will be identified and the Contractor notified before work begins.

Included with these specifications is a list of the roads to be chip sealed along with an accompanying map showing the road locations.

H. Pavement Chip Sealing

The chip sealing process expected through these specifications will consist of a polymer emulsified asphalt blend and a 100% fractured 3/8 granite blackstone which shall not exceed 3/8" in size. Both asphalt and aggregate shall be applied to one half of the roadway at a time to allow for continuous flow of traffic. The polymer asphalt emulsion shall be applied at a minimum of 170 degrees and be evenly distributed by a spray distributor. The road surface shall be cleaned by a self-propelled broom and any necessary cold mix patching installed prior to chip sealing. The finished chip seal shall be rolled and set in place with a duo packer roller.

Cold mix asphalt for wedge patching will be produced using a SC-800 asphalt and a crushed stone and washed sand aggregate mixture with a top size not exceeding 1/2". A separate bid item is shown for wedging and the roads requiring wedging are identified. Estimates of material needed for wedging is provided for guidance. The Town will be responsible for payment of material actually used.

I. Pavement Sweeping

The Contactor shall be responsible for sweeping and removing all loose limestone or granite chip material after the project has been completed. Disposal of loose material shall the responsibility of the Contractor. Pavement sweeping at intersections only shall be completed no later than ten (10) business days after application of the chip seal surface.

J. Damage to Public or Private Property

Should any damage to public or private property occur as a result of the services performed or work done by the Contractor, the Contractor shall immediately notify the Town of such damages. Any damage shall be cured within ten (10) calendar days after the damage occurs unless a different time period is agreed to in the discretion of the Town's representative. Should the damage not be rectified within the time frame agreed upon, the Town reserves the right to repair and/or replace that which is damaged and assess the Contractor for such costs as may be reasonable and related to damage caused by the Contractor, and may deduct these costs from any payment due the Contractor.

K. Contractor Personnel and Equipment

The Contractor shall supply all material, equipment and personnel necessary to complete the work specified. The Contractor shall rent equipment as needed to cover any equipment breakdowns that would cause this contract to not be completed in the allotted time period.

L. Work Crew Supervision

The Contractor shall provide qualified supervision of each crew at all times while working under this contract. Each supervisor shall be fluent in English and be authorized by the Contractor to accept and act upon any directives issued by the Town concerning the work outlined in these specifications and contract.

M. Contract Life

The term of the contract is confined to this project and time frame identified. Any additional work added to the original contract shall be completed at the original contract unit prices and documented through change orders.

N. Working Hours

The Contractor shall schedule work between the hours of 7:00AM and 8:00PM, Monday through Friday, unless otherwise authorized by the Town.

O. Inspection of Work

All work shall be completed to the satisfaction of the Town with respect to proper procedures and quality of workmanship.

P. Unsatisfactory Work

If, at any time during the contract, the Town determines that the service performed or work done by the Contractor creates a condition that threatens the health, safety or welfare of the community or fails to meet the specifications herein, the Contractor shall, upon receipt of the written or oral notice, immediately correct such deficient service or work. In the event the Contractor fails, after notice, to correct the deficient service or work immediately, the Town shall have the right to order correction of the deficiency by separate contract or with its own resources at the Contractor's expense. The Town reserves the right to terminate this contract in whole or in part in the event the Contractor fails to perform any of the provisions of this contract.

Q. Costs and Basis of Payment

The Contractor affirms and states that the prices submitted herein constitute the total cost to the Town for all work identified in these specifications. The total cost includes all insurance, royalties, transportation charges, use of all tools and equipment, supervision, overhead expense, inspection costs, all profits and all other work, services and conditions necessarily involved in the work to be done considered either separately or collectively.

R. Liquidated Damages

The Town and Contractor recognize that time and work quality is of the essence to this contract. The parties also recognize the delays, expense and difficulties involved in a legal proceeding. Should the Contractor fail to complete the work by the date provided in these specifications and contract, the Contractor shall be liable to the Town for liquidated damage in the amount of \$100.00 per day for failure to complete the work in the time frames and specifications provided. All work performed through this contract and specifications is to be completed no later than August 31, 2023.

S. Questions During the Bid Process

T. Failure to Enforce

Failure by the Town an any time to enforce the provisions of this contract shall not be construed as a waiver of any such provisions. Such failure to enforce shall not affect the validity of the contract or any part thereof or the right of the Town to enforce any provision at any time in accordance with its terms.

U. Bid Submission Requirements

Sealed bids will be accepted by the Town of Buchanan until **2:00PM CST, Thursday, April 6, 2023** at the Buchanan Town Hall, N178 County Road N, Appleton, WI 54915 and which time they will be opened and read aloud. No faxed submissions will be accepted. The envelope shall be clearly marked on the outside "**Buchanan 2023 Chip Sealing Services**".

Sealed bid submissions shall include the following:

- 1. Completed Bid Form to these specifications.
- 2. A statement identifying the approximate number of personnel to be working in the Town along with the name and contact information for the foreman assigned to oversee the contract.
- 3. Name, contact information to include address and phone of at least four (4) references outlining the nature of work performed by the Contractor and who can attest to the Contractor's ability to fulfill this contract.
- 4. Certificate of Insurance confirming the minimal level of insurance requirements for the work identified in these specifications.
- 5. Any other information the Contractor feels will be useful to the Town in evaluating their proposal and awarding the work.

1) Price per foot shall include sweeping and clean-up of all excess granite chips by Contractor after application.


2) The Town reserves the right to reduce or increase the lineal feet of chip sealing to maximize the Town's budgeted funds for the work.
