The Town of Buchanan, in cooperation with the Wisconsin Department of Transportation (WisDOT), is proposing to construct a multi-use path along Eisenhower Drive between County KK and Theater Way in the Town of Buchanan, Outagamie County, WI. The proposed project would involve the construction of an 8-foot-wide multi-use asphalt pathway and pedestrian crossings, as well as curb and gutter installation along the west side of Eisenhower Drive and storm sewer improvements within the project limits.

Eisenhower Drive would remain open during construction and no detours would be posted. Temporary lane closures may occur as needed and access would be maintained for residences, businesses, other properties, and emergency vehicles. Construction is anticipated for the summer of 2026. Minimal right-of-way (less than 1 acre) would be required to complete the project.

An in-person Public Involvement Meeting will be held on July 10, 2024, from 5:00-6:30 pm at the Town of Buchanan Town Hall, located at N178 County N, Appleton, WI 54915. Project representatives will be available at that time to discuss the proposed project and address any questions or concerns. A Power Point presentation detailing the project will also be made available on the Town of Buchanan website from June 26 to August 10, 2024. The objective of this Public Outreach is to provide adjacent property owners, interested citizens, and public officials with an opportunity to comment on the design for this improvement.
