

# **Project Update**

## **2024 Contract A-24 Road Construction**

Van Handel Drive

**Project information:** Roadway Construction involving storm sewer/laterals installation, road excavation, road asphalt paving, concrete driveway aprons, curb & gutter installation, storm water management facility construction and landscape restoration.

Timeline: Construction Late May 2024 – August 2024.

**Road Closures, Vehicles & Traffic**: While under construction, the road will be open to local traffic. Travel to the area will be possible, but delays are likely due to construction equipment using the area. Be attentive of construction workers directing traffic through the construction zone.

**Resident Access:** Local resident access to and from your home will be maintained as much as possible during construction. If your driveway needs to be closed while construction is taking place, you will be notified by the Contractor. Please contact the Project Inspector or Town Staff if you require special access needs. **Once concrete is placed for the curb & gutter and the driveway apron, you will not be able to access your driveway for a period of 7 days.** Park on the road or adjacent roads.

**Communication:** It is the intent of the Town to minimize the amount of disruption and inconvenience to the community during any construction process. If during normal work hours you feel something went unnoticed, or needs attention, please contact **Town Staff.** As the project inspector, Town Staff is familiar with daily construction operations and can resolve many issues quickly.

If something happens <u>after normal work hours</u> that you feel requires immediate attention, please contact **Justin Keen or Kyle Johnson**, and arrangements will be made to resolve the issue.

As always, in an emergency, please call 911.
