- 1) CALL MEETING TO ORDER: Meeting called to order by Chairperson McAndrews at 7:00 p.m.
- 2) PLEDGE OF ALLEGIANCE: Pledge recited.
- 3) ROLL CALL & VERIFY PUBLIC NOTICE: Public notice verified. Board members present McAndrews, Lawrence, Kavanaugh and Walsh. Town officials present Town Administrator Brown, Clerk/Treasurer Sieracki, Town Engineers Thad Majkowski and Justin Keen. Supervisor Reinke was present via telephone.
- 4) CAPITAL IMPROVEMENT PROGRAM (CIP) UPDATE: For Approval/Denial- Administrator Brown recapped the PIM with the Van Handel Drive Residents. Engineers Majkowski & Keen reviewed with the Board drainage issues on Van Handel and moving the Tamarack Drive road project to 2018 and placing Van Handel on hold. They also discussed road specifications going forward and financing options. The Board discussed all these items in detail and were in agreement that the drainage issues need to be a number one concern.
