## 2021 Contract A-21 Road Construction

Woodstock Lane/Northbrook Court, Stillwater Trail,  
Main Street/Emons Road (Storm Sewer only)

**Project information:** Roadway Construction involving storm sewer/laterals installation, road excavation, road asphalt paving, concrete driveway aprons, curb & gutter installation, and landscape restoration.

**Timeline:** Construction August 2, 2021 – October 15, 2021 \*Locations will vary.

**Road Closures, Vehicles & Traffic:** While under construction, the road will be closed to through traffic. Travel through the area will be possible, but delays are likely due to construction equipment using the area. Be attentive of construction workers directing traffic through the construction zone.

**Resident Access:** Local resident access to and from your home will be maintained as much as possible during construction. If your driveway needs to be closed while construction is taking place, you will be notified by the contractor. Please contact the Project Inspector, **Cedar Corporation** if you require special access needs. **Once concrete is placed for the curb & gutter and the driveway apron, you will not be able to access your driveway for a period of 7 days. Park on the road or adjacent roads.**

**Communication:** It is the intent of the Town to minimize the amount of disruption and inconvenience to the community during any construction process. If during normal work hours you feel something went unnoticed, or needs attention, please contact **Cedar Corporation**. As the project inspector, Cedar Corporation is familiar with daily construction operations and can resolve many issues quickly.

If something happens after normal work hours that you feel requires immediate attention, please contact **Thad Majkowski**, and arrangements will be made to resolve the issue.

As always, in an emergency, please call 911.

### Two Week Outlook:

Mailboxes will be removed and laid in the yard for the replacement at the end of the Project. Temporary mailboxes will be located at Springfield Drive intersections.

Garbage/Recycle Pick-up will be the same day prior to 7 am; therefore, set the bins out prior to 5 am. This schedule started August 9<sup>th</sup>.

School bus pick up has been coordinated with the Bus Company.

**Week of 8/16/21: Storm sewer installation and striping of ditches. Construction to begin along Emons Road, moving along Main Street and then to Stillwater Trail.**

**Week of 8/23/21: Continue storm sewer with striping of ditches.**
