Emons Road will be closed to through traffic starting Monday, May 2nd until the end of October. You will still be able to access your properties throughout the project. Please access utilizing the closest side road minimizing your travel on Emons Road promoting safety and allowing us to do our work. The following is information to help you during the construction project;

- Mail delivery You will have to remove your mail boxes prior to May 2nd and will have to reinstall them after the project is complete. There are 2 temporary mailbox clusters located @;
 - 2716 Emons Road (East cluster)
 - N294 Pinecrest Boulevard (West cluster)
 - Main Street is the divider.
- Personal Property If you have personal property in the Right of Way or easement please remove as soon as possible. If you do not remove the contractors will remove as part of their grading operations.
- Trash & Recycling Collection Trash collection will continue as normal. Please have your refuse and recycling carts placed roadside by 6:00 am on pickup dates.




Emons Road Project (Pinecrest Blvd to CTH N)


